INFORMATION - RULES & REGULATIONS

- Booth space is limited. MSVB will try to accommodate you on booth selection based on a first-come basis and payment in full.
- All booth space must be paid in advance of the event.
- Booth numbers will be chalked in the street and the layout map will be posted on the MSVB office door on the day of the event.
- Booth spaces are 10' X 10'. You must provide your own tables, chairs and electrical cords. Tents are highly recommended.
- Electricity is at a minimum and available on a first-come basis.
- Hawking is not allowed in the street by City ordinance. Sell/display behind table only.
- No beverages or food items are permitted for sale or to be given away without prior approval.
- Set up begins at 4:00 pm and booths must be ready to open by 5:30 pm.
- Booths may not be broken down until 9:00 pm at the close of the event.
- You are responsible for disposing all of your trash. Do not leave any items behind.
- In the event of inclement weather, the event will be cancelled by 3:00pm and announced on our voicemail message and Facebook page.
- Booth fees will not be refunded or reapplied to another event if you are unable to participate.
